## **Introduction**

This booklet provides a list of FamilyCare Health Plans network pharmacies and includes some basic information about how to fill your prescriptions with FamilyCare Health Plans. To get a complete description of your prescription coverage, including how to fill your prescriptions, please review the Evidence of Coverage.

We call the pharmacies on this list our “network pharmacies” because we have made arrangements with them to provide prescription drugs to Plan members. A network pharmacy is a pharmacy where beneficiaries obtain prescription drug benefits provided by FamilyCare Health Plans. In most cases, your prescriptions are covered under FamilyCare Health Plans only if they are filled at a network pharmacy or through our mail order pharmacy service. Once you go to one, you are not required to continue going to the same pharmacy to fill your prescription, you can go to any of our network pharmacies. We will fill prescriptions at non-network pharmacies under certain circumstances as described later.

## **Can the list of network pharmacies change?**

Yes, FamilyCare Health Plans may add or remove pharmacies from our pharmacy directory. ## **How do I find a FamilyCare Health Plans network pharmacy in my area?**

## **How do I fill a prescription at a network pharmacy?**

To fill your prescription at a network pharmacy, you must show your FamilyCare Health Plans Member ID card. If you do not have your ID card with you when you fill your prescription, you may have to pay the full cost of the prescription (rather than paying just your co-payment). If this happens, you can ask us to reimburse you for our share of the cost by submitting a claim to us. To find out how to submit a claim, look in your Evidence of Coverage or call our Customer Service Department.

## **How do I fill a prescription through FamilyCare Health Plans mail order pharmacy service?**

Ask your physician to write your prescription for the maximum supply allowed by your plan, with the appropriate refills.

Complete the patient profile form. This information will only be required with your first prescription order. Mail your initial prescription, along with payment and patient profile form.

Send in your prescription order at least two weeks in advance of finishing your current medication. To get order forms and information about filling your prescriptions by mail, please contact our Customer Service Department toll free at 866-798-CARE, Monday through Friday, 8:00 a.m. to 8:00 p.m. (TTY/TDD Users should call 800-735-2900.) Please note that you must use the FamilyCare Health Plans mail order service. Prescription drugs that you get through any other mail order service are not covered.

When you order prescription drugs by mail, you may only order a 90-day supply of the drug.

The turnaround time for processing mail orders is approximately one day. For those orders that require follow up, the processing time is approximately two days.

In the event that a maintenance medication is delayed, we will arrange for a short-term supply to be available at a network pharmacy near you. You will not be required to obtain a new prescription. Our Customer Service Department will contact you if your mail order prescription is delayed, no matter what the circumstances are.

You are not required to use mail order prescription drug services to obtain an extended supply of maintenance medications. Instead, you have the option of using a preferred retail pharmacy in our network to obtain a supply of maintenance medications. Some retail pharmacies may agree to accept the mail order reimbursement rate for an extended supply of medications for up to 90 days per dispensing, which may result in no out-of-pocket payment difference to you. Other retail pharmacies may not agree to accept the mail order reimbursement rate for an extended supply of medication. In this case, you will be responsible for the difference in price. Please look in the Evidence of Coverage or call our Customer Service Department for more information.

### **Filling prescriptions outside the network**

Generally, we only cover drugs filled at an out-of-network pharmacy in limited, non-routine circumstances when a network pharmacy is not available. Below are some circumstances when we would cover prescriptions filled at an out-of-network pharmacy. Before you fill your prescription in these situations, call our Customer Service Department to see if there is a network pharmacy in your area where you can fill your prescription. If you do go to an out-of-network pharmacy for the reasons listed below, you may have to pay the full cost (rather than paying just your co-payment) when you fill your prescription. You can ask us to reimburse you for our share of the cost by submitting a claim form. However, even after we reimburse you for our share of the cost, you may pay more for a drug purchased at an out-of-network pharmacy because the out-of-network pharmacy's price is higher than what a network pharmacy would have charged. You should submit a claim to us if you fill a prescription at an out-of-network pharmacy with any amount you pay, consistent with the circumstances listed below. This will help you qualify for catastrophic coverage. To learn how to submit a paper claim, please refer to the paper claims process described next.

The following are a few exceptions when we will pay for a prescription filled at a pharmacy outside of our network:

- Getting coverage when you travel or are away from the plan's service area
- If you take a prescription drug on a regular basis and you are going on a trip, be sure to check your supply of the drug before you leave. When possible, take along all the medication you will need. You may be able to order your prescription drugs ahead of time through our mail order pharmacy service.
- If you are traveling within the United States and territories and become ill, lose or run out of your prescription drugs we will cover prescriptions that are filled at an out-of-network pharmacy. In this situation, you will have to pay the full cost (rather than paying just your co-payment) when you fill your prescription. You can ask us to reimburse you for our share of the cost by submitting a claim form. If you go to an out-of-network pharmacy, you may be responsible for paying the difference between what we would pay for a prescription filled at an in-network pharmacy and what the out-of-network pharmacy charged for your prescription. To learn how to submit a paper claim, please refer to the paper claims process described later.

You can also call Customer Service to find out if there is a network pharmacy in the area where you are traveling. If there are no network pharmacies in that area, Customer Service may be able to make arrangements for you to get your prescriptions from an out-of-network pharmacy. We cannot pay for any prescriptions that are filled by pharmacies outside of the United States and territories, even for a medical emergency.

### **How do I submit a paper claim?**

When you go to a network pharmacy, your claim is automatically submitted to us by the pharmacy. However, if you go to an out-of-network pharmacy because of the reasons listed above, the pharmacy may not be able to submit the claim directly to us and you will have to pay the full cost of your prescription. When you return home, simply submit your claim and your receipt to the following address:
